

## Lamp Post Decorating Guidelines

- Decorations must include a scarecrow and be Halloween/Fall in nature.
- Decorations must not exceed 2' wide on each of three sides of the lamppost
- Decorations may not protrude or block the sidewalk.
- In past years, some of the decorations have been very large and have been hard on the grass at the base of the lamppost. Some decorations have caused the grass to die and the county has had to replant new grass as a result. Please be considerate of this issue when designing your decorations. This is supposed to be a lamppost decorating contest, rather than a lamppost and surrounding ground area decorating contest. If we continue to harm the county's lawn, we may not receive permission to continue this wonderful tradition.
- Poles can be decorated anytime beginning Saturday morning, 10/3 and must be completed prior to PumpkinFest, Saturday 10/08.
- Decorations are to be left up through Halloween and must be removed by November 5<sup>th</sup> by the contest entrant.
- The lampposts are subject to weather damage and/or vandalism. Keep this in mind when decorating since there will be no reimbursement for loss.
- Lamp posts may not be drilled.
- PumpkinFest committee is authorized to remove any decorations in bad taste.
- Please use zip strips to attach decorations to the pole to avoid damage to the pole.
- Decorations should be secured using zip strips or coated wire.
- Banners may not be affixed to the lampposts due to City ordinances. (You may add a small sign no larger than 12"x12" with your organization's name or business name as part of your decoration.)

Judging will be done on Saturday, October 8 at 1:00 p.m. First, Second and Third Place will be decided by our judges and will be awarded at 2:00 p.m. next to the Bandstand. First Place \$50 Chamber Cash; Second Place \$40 Gift Card to a local restaurant and Third Place \$20 Gift Card to a local restaurant.
